Constantin Brâncoveanu nr. 5, Romania, are a trading company supplying sunflower seeds, sunflower kernels, flax seeds, chickpeas and sorghum, as well as other agricultural commodities, to food and feed manufacturers across Europe. By this declaration we confirm that the packaging described below, used for the delivery of our products, complies with Regulation (EU) 2025/40 on packaging and packaging waste (PPWR) and with the applicable EU food-contact legislation.
